- 1. A San Antonio Fire fighter died in a fire last week and another Fire Fighter has burns over 30% of his body and has absorbed toxins from the smoke, which need to be flushed. He is in serious condition.
 - Our thoughts and prayers go out to the Family of the deceased Firemen, the other injured Firemen and his family as well as to all of the members of the San Antonio Fire Dept.
- 2. We are in conducting business as usual.
- 3. We are working on the budget. We will be preparing the 2018 budget to present and vote on in June. We need volunteers to work on it with Chief Zipp and Marilyn.
- 4. We will send 2 Fire Fighters to Texas A&M in July.

Fire Marshal Report/ Emergency Rescue Report – Chief Zipp reported that in April we had 52 total calls, 5 fire related, 398EMS/Rescue related, and 9 other.. Our Avg. Response Time was 7:11 minutes for fire and 8:07 for EMS/Rescue. March was pretty busy.
