Unfinished Business and General Orders

Fire Chief Report – Chief Zipp reported that

- 1. We are doing Firewise safety training county wide with Texas A&M Agrilife Extension. We will be at our station on April 11th at 6:00 PM.
- 2. We sent 1 Fire Fighter to swift water training.
- 3. There was a lightning strike at the new asphalt plant which caused a fire on a conveyor belt. The plant is not in operation yet.
- 4. We took part in the Mass Casualty training at canyon H.S. on March 19th. County wide Fire and Police departments were involved with 75 to 100 participants, and 20-25 mock casualties. Most went well, but we found areas where we still need improvement.

Fire Marshal Report/ Emergency Rescue Report – Bill Anz reported that in February we had 46 total calls, 5 fire related, 41 EMS/Rescue related. Our Avg. Response Time was 8:25 minutes for fire and 7:34 for EMS/Rescue.

1. February was pretty average.

We will no longer use lights and siren for Alarm calls so this will affect our response times. We are doing this to reduce risk of accidents.
