Unfinished Business and General Orders

Fire Chief Report – Chief Zipp reported that

- 1. We had 3.5 to 6" of rain, across the ESD6.
- 2. We brought in extra personnel on Sat. Aug. 26th so we could have 6 Fire Fighters working round the clock for Hurricane Harvey. We also kept all others on call in case of emergencies during the storm. Thankfully we didn't have any serious problems with wind or flooding.
- 3. We were asked to deploy Fire Fighters to the Coast, but we didn't have anyone available since some of our part-time employees had been held back by other FDs they work for full-time due to the Hurricane.
- 4. The Burn Ban has been canceled due to the excellent rain fall we received.
- 5. We have done an inspection on Garden Ridge Elementary and will attend there 1st Fire Drill.
- 6. Our new Web Site is online and working..

Fire Marshal Report/ Emergency Rescue Report – Chief Zipp reported that in July we were about average, we had 60 total calls, only 3 fire related, 36 EMS/Rescue related, and 31 other. Our Avg. Response Time was 7:51 minutes for fire and 7:35 for EMS/Rescue.

Emergency Services District (ESD) Update –No Rep.

- 1. Charlie reported the Commissioners are happy that voted to transfer all property, but we are still waiting on lawyers to complete everything. A title company will draw up all the forms.
- 2. ESD6 is still looking at property for a new station on FM 1863.
- 3. ESD6 commissioners approved BVFD's Budget as submitted.
- 4. ESD6 commissioners approved a new Tax Rate which is lower than the current rate, but will still bring in approximately the same revenue due to higher property evaluations.
- 5. Sales Tax revenue has increased as well.
