Regular Board Meeting

President Charles Flink called the meeting to order at 7:00 p.m.

Recited Pledges of Allegiance to US and Texas Flags.

As the first order of business, minutes of the Oct 8, 2019 General Meeting were presented. Mark Schroeder made a motion to approve and Bob Schoeler seconded to approve with one correction the Treasurer's report from \$32,000 to \$432,000. The motion passed unanimously.

Treasurer's Report – Mark reported our cash on hand, as of Nov. 15, 2019, is \$ 688,718.33. He also reported income was 102.25% of budget, and expense was 70.17 % of budget through 83.3% of the year. Mark made a motion to approve the report, Buddy 2nd the motion. Motion passed unanimously. The complete Treasurer's report is attached.

Unfinished Business and General Orders

Fire Chief Report – Chief Zipp reported that

- 1. Business as usual
- 2. Had a water leak at Station 2 that caused sheetrock damage. Insurance has already paid and we are getting estimates from contractors.
- 3. We have Bunker Gear testing coming up.
- 4. Fire Protection Month finished.
- 5. Doing First Aid Class at City Hall and Citizens Police Alumni.
- 6. We did Halloween Truck or Treat at community center.
- 7. We are working on new maps due to fast growth in the district.
- 8. Working with ESD6 on a Strategic Plan.
- 9. Working on plans for a new truck.
- 10. Several new BVFD memberships.
- 11. Address signs are selling fast, around 75 and more coming.

Activity Report/ Emergency Rescue Report – Asst Chief Anz reported that in Oct. we had 69 total calls, 18 fire related and 51 rescue related. Our Average Response Time was hampered by bad weather; 10:18 minutes for Fire and 6:48 for Rescue at Station1, 13:02 for Fire and 11:33 for Rescue at Station 2. See attached report. Asst Chief Anz also noted that Fire Prevention activity was finished during the first week of November. Saw

over 1000 children. Bracken UMC is doing a Santa visit on 10 December and has requested a fire truck be present.

Emergency Services District (ESD) Update - Randy Maschek

- 1. Approved new fire truck and working on specs.
- 2. ESD plans to pay 100% of cost with no financing.
- 3. The annual Safety Convention will be Feb. 20-22 at Moody Gardens in Galveston.
- 4. The architect for Station 2 is working on plans, ESD might receive electronic version by Christmas.
- 5. The Strategic Planning committee is meeting tomorrow, and has been broken into sub-committees.

New Business

- Discussed the Christmas Party to be held Friday Dec. 6 at 7 p.m. Everything is booked and ready. 876 cards will be sent out. We will have a short meeting and adjourn for the party. We received a notice from Garden Ridge City Parks Committee that they are moving their Christmas tree lighting event to the 1st Friday in December in 2020, and suggesting we move the BVFD Christmas Party to the 1st Saturday in Dec 2020.
- 2. Discussed incentive pay for BVFD full-time and other employees. Buddy made a motion, and Mark 2nd the motion to give the Asst. Chief 1 week pay and \$30 per year of service, Shift Leaders 1 week pay and \$25 per year of service, and other Full Time employees 1 week pay and \$20 per year of service, and part time employees get gift card at the Chief's discretion. The motion passed unanimously.
- 3. Charlie closed the regular meeting to go into executive session at 7:35 and reopened the regular meeting at 7:46.
- Mark made a motion to give the Chief an incentive pay of 1 week pay and \$35 per year of service and a 4% raise. Buddy 2nd the motion. The motion passed unanimously.
- 5. Buddy made a motion to give our Bookkeeper incentive pay of \$350 and a pay increase of \$1.00/hr. Bob 2nd the motion. The motion passed unanimously.
- A slate of officers for the BVFD Board of Directors for 2018 was nominated. President: Charlie Flink Vice President: Kurtis Wilcox Treasurer: Mark Schroeder Secretary: Jim Moreland

Buddy made a motion to accept the slate as presented, Bob 2nd the motion. The motion passed unanimously.
