Minutes – Meeting of the Bracken VFD Board of Directors Monday, May 18th, 2020

Regular Board Meeting

President Charles Flink called the meeting to order at 7:00 p.m. via ZOOM video conference due to COVID-19 Pandemic public meeting restrictions.

Pledges of Allegiance to US and Texas Flags were suspended due to this meeting being held by video/teleconference.

Minutes Approval – As the first order of business, minutes of the April 2020 General Meeting were presented. Bob Schoeler made a motion to approve and Rick Shimon seconded. Motion passed unanimously. The April meeting was held via internet (ZOOM) due to COVID-19 meeting restrictions.

Treasurer's Report – President Flink reported on behalf of Treasurer Schroeder. As of May 23, 2020, cash on hand is \$537,388.68. Income was 50.1% of budget and expenses were 30.1% of budget through 33.3% of the year. The March report was also reviewed and approved (no meeting in March due to COVID-19 meeting restrictions). As of March 23 2020, cash on hand was \$420,964.94. Income was 26.7% of budget and expenses were 16.2% of budget through 16.7% of the year. Bob Schoeler made a motion to approve both reports, and Rick Shimon seconded the motion. Motion passed unanimously.

Unfinished Business and General Orders

Fire Chief Report – Chief Zipp reported that the Main Station remodel is underway. Station admin functions are being relocated to a CONEX box behind the Main Station during construction. Everything is still on schedule. COVID-19 precautionary procedures remain in place for our fire fighters. No COVID-19 positive tests among BVFD personnel. Marilyn Winters reported she will be moving her BVFD computer to her office and working remotely, as there is insufficient room in the CONEX.

Activity Report/ Emergency Rescue Report – Asst Chief Anz reported that in April we had 53 total calls, 11 fire related and 42 rescue related. Average response time was 6:21 for fire response and 6:53 for emergent response. See attached reports.

Emergency Services District (ESD) Update – There were no ESD members present, but President Flink reported that ESD 6 awarded a \$1.68M contract for the Delafield Station construction. Seidel Construction out of New Braunfels was the successful bidder.

New Business

- 1. Discuss and take action as necessary on the Armstrong Vaughn audit. Marilyn Winters reported that the field work is complete, but not the final report. During the audit of BVFD, the auditor found that the repayment to the ESD for 2019 was incorrect. Marilyn Winters reported that she inadvertently used a weekly cash report from 1/21/2020 instead of changing the report date to 12/31/2019. This resulted in an underpayment of \$47,458.25 when the BVFD returned funds to the ESD 6 at the end of the year. Marilyn Winters reported that a check was written to the ESD for this amount to correct the problem. (See attached email.)
- 2. Open floor comments: President Flink outlined the budget process for the year 2021. The ESD needs BVFD BoD input in approximately one month. President Flink invited any of the BoD members to participate in the Finance Committee effort to develop the 2021 budget. Anybody interested should contact President Flink. The Finance Committee will put the budget documents together for discussion and approval at our June meeting. Finance subcommittee will meet 2d and 3d week of June to get the budget ready for approval at our June meeting followed by transfer to the ESD 6 Commission.
- **3. Roundtable:** No new input.

Adjourn


